- 2. The Meeting will be governed by the General Regulations of the Motor Sports Association Ltd., (incorporating the provisions of the International Sporting Code of the FISA), these Supplementary Regulations and any written instructions that the organising Club may issue for the event.
- 3. MSA Permit Number Nat B TBA & Clubman TBA has been issued.
- 4. The event is open to all fully elected members of the organising Club and members affiliated to the ANICC or Motorsport Ireland
- Class 1, 2, & 3 competitors must produce a valid Competition Licence and Club Membership Card; Class 4 competitors must produce a valid NAMC membership card.
- 6. The event is a round of the North Armagh Motor Club Championship, & The McGrady Insurance N.I Navigation Rally Championship 2015
- 7. The Programme of the Meeting will be:-Scrutiny starts at 19.00 hrs. Individual times of scrutineering will be notified in the Final Instructions. Any competitor not signed on by 20.30 hrs may be excluded. First car starts at 21.01 hrs.
