



FINAL INSTRUCTIONS 1

Tuesday 4th July 2017

1. Thank you for your entry. Your Competition number and class entered will be available from **www.namcc.com** on Wednesday 5th July 2017
Please check you have been entered in the correct class.
2. SCRUTINY: - Scrutiny will be held on **Friday 8th July 2017** at Loughgall Country Park (Map Ref. 19/ 908520) from 6.00pm. Limited Saturday Scrutiny will be available for those who have already requested it. **Overnight parking in the service area will be available and will be manned by Security.**

Please arrive for scrutiny as per scrutiny time table issued on **www.namcc.com** from Wednesday 5th July 2017 and **PARK AS DIRECTED BY THE MARSHALS.**

Documentation will take place at the Golf Club Pavilion beside the scrutiny venue

At Scrutiny it will be necessary to present the following items for the competing car:-

- a. A current MOT certificate
 - b. Vehicle registration book
 - c. Log book
 - d. HANS Device for both competitors
 - e. Seats and Seat Belts as current MSA regulations
3. Competitors are reminded that the correct grade of licence must be produced at signing-on.i.e (Drivers must hold a valid Stage Rally National 'B', Stage Rally National 'A' or Rally International licence (**Drivers with NON RACE Licences will not be allowed to Start**) and the Co Driver must hold a Non Race National 'B', Stage Rally National 'B', Stage Rally National 'A', Stage Rally National 'A' Navigator or a Rally International licence) **Applications for licences for Drivers can not be made at signing-on, although fully completed applications including correct fee and photograph will be accepted for co drivers.**

All Competition Licences must be signed by the holder and a passport-type photo must be affixed to it.

4. The organisers will supply competition numbers/plates including side window numbers and you are advised to fix these numbers/plates prior to scrutiny.

5. In accordance with the regulations you will be permitted to make a reconnaissance of the Stages on Friday 7th July between 4 p.m. and 9 p.m. and Saturday 8th July, between 6.30 a.m. and 8.30 a.m. This may only be done while walking or on bicycle. **No Golf Buggies allowed.**
6. Following MSA approval **Patterson's Safety Notes** will be available for use on the event and these will be available to purchase from them beforehand and at at Signing on Friday evening.
7. Due to space restrictions in the service area only one service van will be allowed into the service area, trailers will be parked adjacent to the service area, follow the directions given by the marshals
8. All cars must be in the service area no later than **8.15 a.m. on Saturday 8TH July.**
9. There will be a drivers briefing at 9.00 a.m. which will be held outside the rally office in the service area. Starting times will be posted at the rally office at 9.00 a.m. with the first car starting at 9.30a.m.
10. A list of Judges of Fact will be available at Documentation on the morning of the event.
11. Results will be published and prizes awarded when the results become final at Loughgall Football Club. (approx. 500m from the Loughgall Country Club entrance).
12. The following amendments/additions to the Supplementary Regulations
 - S.R. 3: - MSA Permit Number 102173
 - S.R.18: - M.S.A. Steward – Robert Kelly
 - New S.R. 31 **Patterson's Safety Notes** will be available for purchase by Competitors.
13. Road Traffic Act Insurance will not be required for the event, as it does not use the public highway.
14. All competitors must produce a 2017 North Armagh Motor Club Membership card
14. Please ring me if you could supply someone to Marshal at the event.
15. Anyone who fails to finish a stage must seek permission from the Clerk of the Course and pass Scrutiny again if they wish to restart the event.
